### **What do I need to take with me when traveling to New York State for an IDPA Competition?**

The requirements for traveling with a pistol or handgun by a person who is not a resident of the State of New York is defined by NYS Penal law 265.20. further, the specific part of the NYS Penal Law that covers the exemption is 256.20.a.13 which is reproduced below. based on this section you should have:

1. A clean record according to law enforcement
2. A lockable opaque container to carry you unloaded pistol or revolver
3. A copy of the match program, match schedule or match registration card
4. A pistol or firearms license/permit issued in accordance with your place of residence

Please review our individual state's Penal laws to insure compliance as Chesterfield Fish & Game Club will not be held liable for any failures to comply. The following has been taken from NYS Penal Law:

NYS Penal Code § 265.20.a.13 [[Reference Link](#)]

13. Possession of pistols and revolvers by a person who is a nonresident of this state while attending or traveling to or from, an organized competitive pistol match or league competition under auspices of, or approved by, the National Rifle Association and in which he is a competitor, within forty-eight hours of such event or by person who is a non-resident of the state while attending or traveling to or from an organized match sanctioned by the International Handgun Metallic Silhouette Association and in which he is a competitor, within forty-eight hours of such event, provided that he has not been previously convicted of a felony or a crime which, if committed in New York, would constitute a felony, and further provided that the pistols or revolvers are transported unloaded in a locked opaque container together with a match program, match schedule or match registration card. Such documentation shall constitute prima facie evidence of exemption, providing that such person also has in this possession a pistol license or firearm registration card issued in accordance with the laws of his place of residence. For purpose of this subdivision, a person licensed in a jurisdiction which does not authorize such license by a person who has been previously convicted of a felony shall be presumed to have no prior conviction. The superintendent of state police shall annually review the laws of jurisdictions within the United States and Canada with respect to the applicable requirements for licensing or registration of firearms and shall publish a list of those jurisdictions which prohibit possession of a firearm by a person previously convicted of a felony or crimes which if committed in New York state would constitute a felony.

#### **Canadian Border Crossing:**

In addition to following the NYS Penal Code laws stated above, for those traveling across the Canadian Border you will need to secure the ATF-F-5330.3D (6NIA Form) documentation.
